#### **GENERAL TERMS AND CONDITIONS:-**

- 1. The work shall be carried out as per CPWD specification, Special Conditions with fabrication and supply exactly as per existing furniture item at site.
- 2. Any damage done to the equipment/building during execution of work shall be on the part of contractor.
- 3. No T&P shall be issued to the contractor.
- 4. Time allowed : 21 days.
- 5. Schedule of quantity : As per Annexure- 'A'
- Contractor must visit site before quoting and fully satisfy himself of the site conditions. No Compensation on account of any site difficulties will be entertained, at a later date, after award of the work.
- 7. No T&P shall be issued to the Contractor. The contractor shall be provided with electricity and water at one point, he shall make his own arrangements for further distribution of electricity, water supply and all other labour ,tools, plant and equipment etc as required for the works complete. Any damage done to existing walls /ceiling /floors /electrical /fire alarm/ fighting/plumbing equipment /building during execution shall be on the part of the Contractor.
- 8. Contractor should depute a qualified supervisor dedicated for this work, who will monitor and coordinate work from contractor's side and interact with the IIITD Engineers, responsible for supervision of work, on regular basis.



- 9. Eligibility Criteria: The agencies who have carried out similar Furniture/ Interior work in Govt Deptts/PSU/Reputed Pvt sector /MNCs a three works each of value of Rs 1.20 Lac or two works each of value 1.80 Lac or one work of value 2.40 Lac during last 5 years to submit the experience certificates for the works and registration certificates with Govt. Depts. if any. The said certificates along with the EMD be enclosed in Envelope-A. The applications not supported with requisite experience certificates shall not be entertained
- 10. The priced bill of quantities kept in Envelope-B, all duly signed by the authorized signatory of the firms.
- 11. Payment shall be made as per actual quantities of executed works. Security deposit @5% shall be refunded after 6 months of defect liability period. The items shall be covered under defect liability for a period of one year from the date of supply.
- 12. Contractor will take due permission for entry of all his workers in IIITD. No unauthorized person will be allowed to work inside.
- 13. During execution of work, Engineer may make minor changes in the scope of work as per site conditions or other reasons. Contractor will have no extra claim in his rates for the same.
- 14. All standard protocols such as wearing masks, using sanitizer, maintaining safe distancing norms must be followed by the Contractor and his workers to prevent spread of coronavirus failing which expulsion/ penalty shall be levied on the agency
- 15. The workers shall be scanned for temperature before entry as per norms and actions per policy taken
- 16. All are supposed to use identified utilities of the Institute only
- 17. Conditional offers will not be accepted. The offer shall remain valid for 60days.
- 18. Rates to quoted are inclusive of all taxes, duties, cartage , loading unloading and shifting to location as called for.
- 19. IIIT-D reserves the right to accept or reject any tender in part or whole without assigning any reasons thereof.




