Indraprastha Institute of Information Technology -Delhi (IIITD), a State University created by an Act of Govt. of NCT of Delhi, invites sealed bids for **Annual maintenance contract (CON-SNT) of Cisco Access Points** (as per specifications mentioned under Scope of Work below) for its campus at Okhla Phase-III New Delhi-110020.

- 2. The tender document can be downloaded from the Institute's web-site. Those wishing to get the copy of the document from the Institute may please deposit non-refundable Tender Document Fee of Rs.1,180/- (Rupees One Thousand One Hundred eighty only) in the form of Demand draft drawn in favour of IIIT-Delhi Collections", payable at New Delhi or may deposit Rs.1,180/-with the F&A division of the Institute and enclose the receipt with the filled up tender document. Tender fees is exempted for MSMEs/NSIC registered suppliers.
- 3. The last date for submission of bid is 2<sub>3rd</sub> Feb, 2021 up to 3:00 PM. The technical bid will be open on same day i.e 23<sup>rd</sup> Feb, 2021 at 3:30 PM. The Tender Document should be addressed to:

The document may be deposited in the Tender Box kept in the Store & Purchase department at the Room no. A-107, First Floor, Old Academic Block of the Institute. Bids received after 3:00 PM will not be accepted or considered under any circumstances.

#### **Bidding Procedure:**

1. Bids are invited in Two Bids System i.e. (1) Technical and (2) Financial.

Technical and Financial bids should be sealed separately and enclosed in a sealed envelope clearly indicating separately Technical Bid for "ANNUAL MAINTENACE CONTRACT (CON-SNT) OF CISCO ACCESS POINTS" and Financial Bid for "ANNUAL MAINTENACE CONTRACT (CON-SNT) OF CISCO ACCESS POINTS " addressed to Registrar IIIT-Delhi, Okhla Industrial Area Phase-III, New Delhi-110020.

- 2. Sealed quotations shall be received not later than 3.00 P.M. on 23<sup>rd</sup> Feb, 2021. No bids will be accepted after this date & time under any circumstances. The Institute will not be responsible for any postal/courier delay and also for reasons beyond control of the Institute.
- 3. Technical bids must contain the EMD for specified amount, along with complete technical details as desired by this tender. Technical bids of all the tenderers will be opened on pre scheduled date, time & venue. Technical bids without EMD will be summarily rejected. The financial bid will be opened after evaluation of the technical bid. Financial bid of only those meeting the requirement of the Institute will be opened and no representation in this regard will be entertained. The date, time of opening of financial bid will be communicated later.

## **Minimum Eligibility Requirement:**

- 1 Bidder should be OEM/Authorized Partner/service provider of the OEM. In case the tenderer is an Authorized Partner or Service Provider a valid Agency-ship/Dealership Certificate (MAF specific to this tender) to quote on behalf of OEM should also be enclosed along with the technical bid. <u>A document in support of this must be enclosed.</u>
- 2 OEM/bidders should have Sales and support office in Country. <u>A self-certified</u> <u>document in support of this must be enclosed.</u>
- 3 OEM/bidder should have service and support office in Delhi NCR. <u>A self-certified</u> <u>document in support of this must be enclosed.</u>
- 4 The warranty provided by the bidder should have a back to back arrangement with the OEM. <u>The declaration should be the part of a Letter of Authorization and signed by competent authority at the OEM</u>.
- 5 The bidder should be ISO 9001 certified. <u>A copy of ISO Certificate should be</u> enclosed.
- 6 The bidder should have support center with minimum 3 network wireless support engineers. <u>A self-certified document in support of this must be enclosed.</u>
- 7 The vendor/OEM should be able to provide 24x7 NOC & Tele support of their own if required by IIITD at agreed terms. <u>A self-certified document in support of this</u> <u>must be enclosed.</u>
- 8 The bidder shall provide the Registration number of the firm along with the valid GST number with PAN Number allotted by the competent authorities. <u>A self-certified</u> <u>document in support of this must be enclosed.</u>
- 9 The bidder must not be blacklisted by Central Government, State Government or Government of Corporations in India. <u>A certificate or undertaking to this effect</u> <u>must be submitted.</u>
- 10 If the bidder is an authorized partner or service provider of an OEM, <u>an undertaking</u> <u>from the OEM is required</u> (please enclose) stating that they would facilitate the bidder on a regular basis with technology/product updates and extends support for the warranty as well.
- 11 The bidder must be responsible for supply, deploy and support the infrastructure.
- 12 If vendor /OEM do not meet its SLA, IIITD put the fine of 2000/- Rs per day for first seven days and @ Rs.5, 000/- per day from 8<sup>th</sup> day onwards will be levied.

### TERMS AND CONDITIONS

- 1. The financial bid should be valid for a period of not less than 60 days from the date of opening of bid.
- 2. Upon placing of the Purchase/Work Order, the successful bidder is required to submit performance Bank guarantee (PBG) equivalent to 3% of the PO value within 07 days of the date of PO, failing which the EMD amount will be forfeited and the bidder shall be notified as blacklisted. The PBG shall be valid for a period of 60 months from date of purchase order.
- 3 The confirmation of the AMC should be provided within a period of 1-2 weeks from the date of the Purchase order by the institute.
- 4 The bidder should have their own test and repair facility with certified engineers.
- 5 No interest is payable on the PBG.
- 6 PBG will be realized by IIIT-D in case of termination of the contract for unsatisfactory performance and/or non-performance of the contract.
- 7 Bids will be opened in the presence of bidder's representatives, who choose to attend on the specified date and time. Only one representative shall be allowed to attend.
- 8 Sealed bid can be sent either by post or by messenger. The responsibility of delivery of bid lies entirely with the bidder.
- 9 Advance Payment will be released on yearly basis in five equal installments each year (i.e. 2020-21, 2021-22, 2022-23, 2023-24 & 2024-25) after producing the GST invoice. Further Payment will be release, if required SLA met as per tender scope of work as certify by officer in charge of the Institute. Bidder does not agree to above payment terms are requested not to submit their bid.
- 11 The selected bidder has to ensure that the problem reported and or equipment fault developed in the items under the AMC is resolved /rectified promptly within two working days of reporting the call. If the firm fails to do so, a penalty of Rs. 2,000/- per day will be imposed for each day of delay subject to a maximum of 30% of the awarded contract value.
- 12 In the event of dispute, Director, IIIT-Delhi shall be the sole arbitrator and his decision shall be final and binding on both the parties.
- 13 IIIT-Delhi does not bind itself to accept the lowest or any other offer and reserves the right to accept or reject any or all the offers either in full or in part without assigning any reason.
- 14 In case the bidder is not able to execute the Work as per terms, EMD/PBG shall be forfeited.
- 15 The bidder must be an ISO-9000 certified organization.
- 16 The bidder should be Original Equipment Manufacturer (OEM) or authorized service provider of the OEM (attach documentary proof). The authorization issued by the OEM must be valid and enclosed.
